All reservation fees will be assessed 5% Lodging Tax & 5% Sales Tax for your stay at the Uinta County Youth Camp. If your reservation request cannot be fulfilled due to number of initial applications, you will receive a full refund including the sales & lodging tax. If you are a non-profit, religious, or charitable organization and are not required to pay sales or lodging tax, the Uinta County Treasurer **must have** on file a properly completed and signed SSUTA Certificate of Exemption with the Revenue Identification Number to be considered for an exemption. Payment must come directly from organization, payment by an employee or other person pending reimbursement establishes that the person is acting on their own behalf and voids any claim of exemption.

## Lodge & Cabins:

The Lodge/Cabin area can accommodate up to 140 people and has a lodge, kitchen and dining/recreation area with a large fireplace, shower house/restrooms and the warming hut off a large open-air patio with grill. There are 12 cabins with single bunks per cabin (sleeps 10-12) play area, horseshoe pits, tetherball and a basketball standard.

## Yurt:

The Yurt is about a mile away from the lodge/cabin area but is accessible by car or truck during summer months. It is a canvas structure on a deck and will sleep up to 8 people. It has an outhouse, fire ring, picnic table and cooking area with grill. There is no electricity or running water at the yurt but propane and some water are provided.

Please note a \$10.00 fee per dog per day is required. Dog Fees will be due upon check-in at the Youth Camp.

If you choose to fish at the Youth Camp Fishing Preserve Pond, a \$5.00 fee per day per person will be charged, whether the fish are kept or released. This fee can be paid at a self-serve kiosk located at the Fishing Preserve Pond.
